The book **argues convincingly** that postcolonial Zimbabwe's economic development is hurt by the strength of former white settlers, allied to international capital, and threatened by neighboring South Africa, to which Zimbabwe is linked by trade and transport. According to the book, Zimbabwe's African leadership, lacking the power to confront local whites and foreign business, pleads for unity and patience and stresses the progress since colonialism, rather than responding to labor and peasant dissatisfaction. ...**Supersedes** Michael G. Schatzberg, ed., The political Economy of Zimbabwe 1984, which is less current and detailed than Mandaza. **Excellent bibliography.** Index.

The book comprises of thirteen chapters divided into sections on politics, the economy, the agrarian question, the labour movement and social development. It is a book on Zimbabwe written entirely by Zimbabweans.

The political economy on transition is an **essential purchase** not only for the sharp insights that it provides into post-independent Zimbabwe but also as an historical document of - to paraphrase Amilcar Cabral - the **struggles that mark Africans, return to their history...**
